SPECIAL NOTES

- Inspection fee is NON-REFUNDABLE once the screening process begins and/or the homestay is not approved for not meeting Global **experience**'s standards.
- An annual revisit fee is applied each year the student is with the nominated family.
- Nominated homestay/carers must provide a supportive family environment for students and must meet the same requirements that apply to all Homestay host families.
- Homestay/carers must be over the age of 25 and be a resident in Australia at least until the student is 18 years of age.
- Approval will not be granted to people who often travel overseas. Nominated carers are required to inform us if they intend to travel overseas.
- The nominated homestay must be within reasonable travelling time from your child's educational institution.
- Your child must not move into the nominated homestay until approval is granted.
- If your child is currently staying in a homestay, a two weeks' notice must be given to the current host.

PARENT AGREEMENT WITH Global experience

All nominated homestay families must meet the following requirements:

1. The home must be clean and have appropriate furnishings suitable for students.
2. The homestay host(s) must reside at the homestay premises.
3. The main carer must attend Global **experience** mandatory training sessions.
4. The main carer must inform Global **experience** if he or she decides to go on a holiday.
A temporary carer must provide a valid working with children check.
5. Each student is to have (as a minimum) their own room, bed, desk, lamp and wardrobe.
6. Students are not to share rooms with host family members.
7. Room sharing arrangements with another student will only be provided if requested by the parent(s) of the students.
8. Rooms assigned to students are solely for the student's use and not for the use of other family members that requires regular access such as storage.
9. The total number of students that the family can host is up to three (3) students and
10. Students are to be given a set of keys to gain access to the home at any time,
11. There must be adequate access to the common areas such as bathroom, kitchen and dining area plus laundry facilities.
12. There must be adequate access of cooling (during summer) and heating (during winter) for the students.
